PRINT SERVICE AGREEMENT

1. I understand that each item must be reproduced in its entirety and the reproduction may not be bled off or altered in any way. Nothing may be superimposed on the reproduction. Reproductions may not be printed in colored ink or on colored stock. Permission to reproduce a detail will be granted only if the entire image also appears in the same publication. Application to reproduce a detail from a work will be considered only upon receipt of a photo copy or photograph marked to show the area to be reproduced. If a detail is used, the caption must include the word "detail."
2. I understand that on occasion requests for copies may be denied because of copyright regulations or physical condition of the items.
3. I understand that The University of Texas at Arlington Libraries, Special Collections Division, assumes no responsibility for any royalties claimed by the creator of the items or on his behalf.
4. I agree to assume all responsibility for clearing reproduction rights and for any infringement of the U.S. Copyright Code. I also agree to protect the rights and privacy of all subjects depicted in the materials furnished.
5. I agree that if permission is granted for the publishing party itself to photograph any visual material in Special Collections, all such negatives will be turned over to Special Collections.
