COURSE DESCRIPTION

Explores the principles of Universal Design using the performing arts as a case study: creating environments, events, buildings, and products to accommodate the broadest spectrum of human ability, size, age, and other characteristics. Investigates how to put into practice the accessibility guidelines of the Americans with Disabilities Act of 1990. Performing is not required. Offered as THEA 3355 and DS 3355; credit will only be granted in one department.

STUDENT LEARNING OUTCOMES Upon completion of this course, students will be able to:

- 1. summarize accommodations and adaptations related to the Americans with Disabilities Act of 1990
- 2. recognize potential accessibility challenges when creating theatre productions
- 3. identify tangible and intangible benefits and challenges of working toward universal accessibility
- 4. operate effectively in a collaborative environment
- demonstrate observational, verbal, and written skills necessary to analyze a work of theatre for form and content and identify ways in which it might be related to both theatre arts studies and disability studies

HIGHER-ORDER OUTCOMES (application, analysis, synthesis, and evaluation) are assessed by completing the following:

- 1. attend 1 performance of 1 production presented this semester by UTA's Maverick Theatre Company
- 2. attend another performing arts event of student's choice (art exhibit, film screening, play, dance production, etc.) with the goal of discussing accessibility observations in class
- 3. complete 4 open-note, untimed quizzes
- 4. demonstrate ability to work collaboratively to make accessibility decisions in theatre by creating a universally-accessible presentation. The project is completed through collaboration with classmates and serves as the final exam.

GRADING SCALE, GRADE GRIEVANCES

EXPLANATION OF MAJOR ASSIGNMENTS

Quizzes - 5 @ 10 points each = 50 points total (weighted at 60%)

Quizzes are listed on the calendar. They are open-note and open book, but not open-internet nor are they a group activity. Quizzes are designed to assess understanding of concepts derived from the reading and from class activities. The goal is to apply knowledge and reflect. During the quiz, use of outside resources other than one's book and notes are prohibited. **Plagiarism checks are in effect, so students may be required to cite sources used.** Students have unlimited attempts up to the due date and time, and the last attempt posted by the due date and time is graded. Expect multiple choice, multiple answer, short answer, longer answer, and true/false questions. Point values are always provided on the quiz itself

Observations + proof of attendance at 1 UTA Maverick Theatre Company play - 25 points (weighted at 20%)

The objective of this critique is to communicate to people who have not seen the same play why it is accessible and why it isn't, using specific evidence from the performance and focusing on specific aesthetic qualities of the play. Additionally, students who've not seen the play being discussed are responsible for asking questions that challenge the speakers presenting that day. Students must also bring and show proof of attendance. **RUBRIC**: below

Volume is loud enough to communicate ideas. Presence indicates preparation.

Student's Choice of performing arts event – 15 points (weighted at 10%)

This assignment is a presentation of a student's experience attending a performing arts event. Students will attend a <u>performing arts-oriented</u> event of the their choice with the goal of discussing accessibility observations. What kinds of events qualify? Any artistic endeavor in which an audience is present for the performance, e.g. music event, a play, a dance production, comedy improvisation, etc. is eligible. **Movie-going is not an eligible event for this assignment.** Observations will be discussed with the instructor in a small-group setting. Sign-up sheet provided.

Final project (serves as final exam) — 40 points per team member (weighted at 10%)

We use a specific format called "Design Thinking" from IDEO.com. The format will be posted on Blackboard and we will have practiced in class. The format is designed to generate ideas based upon consumer-driven information. The goal of this process is to ensure we are incorporating consumer input in universal design decisions. We will present our consumer-driven ideas to the class and the people for whom they are designed. Students must (aka "get to") create a solution using the UTA FabLab. Training provided, tours provided.
